For IDM we will focus on Document Output, showing how you can turn your data in to documents that you can store, email, print or get eSignatures on - connected of course to Workflow tasks if required.</div>	<div>Jill Papendick</div> <div>Kevin Heiman</div> <div>Data Fabric: Everything you need to know series - Data Fabric: What is it and what can I do with it? We'll walk through the core principles and building blocks of Data Fabric. Discuss all the security features that let you secure the data stored, making the right data available to the right systems. We'll also dive in to all the ways you can use your data while in Data Fabric, perhaps to drive Birst, some custom widgets or for use with external tools, reporting, integration, etc.</div> <div>Finally we'll make sure to highlight any new capabilities added to Data Fabric over the past few releases, ending with a brief discussion on what is to come.</div>	<div>Ron Heusser</div> <div>Finance Foundations - Finance Module and Costing Items: Detailed review of the ‘foundation’ for financials, including Chart of Account setup and Unit Code flexibility, will provide the basis for financial reporting. Reviewing the transaction flows to the General Ledger, how distribution accounts can be structured, and how Distribution Journals can be leveraged, will provide visibility to transactional data and how adjustments can be made. Additional reviews to include Product Codes and automation tools will provide increase insight. Reviewing financial statement report options, including recent CSI enhancements, will show how financial information can be generated. Additional reviews will include budgets & multi-books. From a costing perspective, reviewing the item cost options and parameters will provide visibility to costing options. Review of cost related transactional data, how costs are categorized, and variance analysis will provide additional detail into the costing process.</div> <div></div>
